This regiment, recruited in the counties of Fulton, Montgomery, Saratoga, Clinton, Essex and Warren, was organized at Fonda and there mustered into the U. S. service on Oct. 18, 1862, for three years. It left the same day for Washington, was first stationed at Alexandria as provost guard, and during most of the year 1863, did garrison and guard duty about the capital. It was then transferred to the Department of the Gulf, where it was assigned to the 1st brigade, 1st (Emory's) division, 19th corps, with which it took part in the Red River campaign, meeting with severe loss at Pleasant Hill. It was active at Mansura and was warmly commended for its bravery in these battles by the commanding general. In July, 1864, it returned to Virginia with the 1st and 2nd divisions; on its arrival at

Washington it was ordered into Maryland to confront Gen. Early; and then served with Sheridan in the Shenandoah Valley, taking part in the battles of the Opequan, Fisher's hill, Strasburg and Cedar creek, besides numerous lesser skirmishes. Its loss at the Opequan was 69 killed and wounded, and at Cedar creek, 81 killed, wounded and missing. The regiment continued to serve in the valley until April, 1865, when it moved with Dwight's division to Washington, where it participated in the grand review in May. In July it sailed for Savannah, Ga., and while stationed there won the esteem and respect of the citizens by the gentlemanly conduct of its officers and men. Col. Davis was brevetted brigadier-general for meritorious service. The regiment was mustered out at Savannah on Oct. 2, 1865, under command of Lieut.-Col. McLaughlin. It lost during service 1 officer and 40 men killed and died of wounds; 1 officer and 160 men died of disease and other causes; total deaths, 202.

Born: 29 March 1825

Baptized: As Jean Dagneau-Laprise on 30 March 1825 at St-Henri-de-Lauzon, Quebec. Parents were Jean & Susanne Beaudoin

Naturalized: 3 Sep 1867 at Burlington, VT (says born in 1830) actually in 1825

Married: John Dano married on 2 Apr 1883 at age 63 (actually age 58) in Burlington to Leonora Miller St-Jean age 43. It was her 2nd marriage. Her parents were Olivier St-Jean dit Coitou and Eleonora Omond/Aumond who were married at St-Esprit, Quebec.

Death: Died on 17 Jun 1887 in Shelburne, VT at age 67 (actually age 62) father was John and mother was Susan Bowdin. (Actually Suzanne Beaudoin)
